## EXTENDED CARE PROGRAM GRADES KINDERGARTEN THRU EIGHTH 2021-2022

Dear Parents,

The purpose of extended care is to provide a place for those children who need supervision after school hours until their parents can pick them up. Unlike day care, we will not have extended care before school hours or hours when OLM School is not in regular session.

Children eligible to attend <u>must be</u> registered in grades K-8 for the 2021/2022 school year and have the completed enrollment form on file.

Please read and complete the attached registration form and return it to the main office. Remember, you must be registered for classes before we will accept registration for extended care.

RATES: Rates have been calculated on a 20-day month. This will average out for the short and long months throughout the school year. There is no additional charge for minimum days. There are no discounts given for the months with holidays. Families will receive a 25% discount rate if child/ren are picked up every day before 4:00 pm. Please let the director know if this applies to you. \*\*\*Take note, the late fee policy will take affect at 4:01 pm.

**Drop-in Services:** Drop in services is available for \$10 per hour, per day, per child. Minimum daily charge is \$10.00 per child. **Payment for drop-in services is due at the time that you pick up your child.** 

PAYMENTS: Extended care payments are separate from your SMART Tuition account. Your payments will be made directly to OLM School office on the first of each month. You can send payment to the office or they can be given to Mrs. Faraone.

When school is dismissed, all children in grades K-8 that are in the extended care program are to report to room 22. Our room is located next to the library. The extended care staff will have specific check in and check out procedures. The staff will be responsible for the child/ren until the parents have signed them out to go home. However, the extended care staff will not be responsible for children who do not check in by 2:45 pm.

TIMES OF SERVICE:

2:30 to 5:30 pm 12:30 to 5:30 pm regular day schedule minimum day schedule

LATE PICK-UP CHARGES: A late fee of \$10.00 will be charged <u>per</u> child for <u>any</u> portion of the first 10 minutes you are late. An additional \$2.00 <u>per</u> minute will be charged for every minute there after. This late fee policy also applies to those families who have signed up for the 4:00 pm pick-up. Late fees are to be paid at the time of pick-up.
